ADDITIONAL RULES

- TELEGRAPH, TELEPHONE, AND UNSIGNED ENTRIES CANNOT BE ACCEPTED. Entries not on official AKC entry forms and photocopies of entry forms without the agreement and rules on the reverse side of official AKC entry forms are NOT ACCEPTABLE.
- ENTRIES WITHOUT FEES will NOT be accepted. Make all checks payable to the GREEN BAY SHETLAND SHEEPDOG CLUB, INC. Please do not send cash. There will be a \$25 fee for returned checks.
- NO ENTRY SHALL be made and no entry shall be accepted which specifies any conditions as to its acceptance.
- ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the show committee. If because of riots, civil disturbance or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
- NO REFUNDS FOR DUPLICATE ENTRIES. We will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made.
- ERRORS ON ENTRY BLANKS: Owners are responsible for all errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published date of closing.
- FEES include the 50¢ AKC Recording Fee & the \$3.00 AKC Event Service Fee on the first entry of a dog and a \$3.00 AKC Event Service Fee for each additional entry of the same dog in the regular & non-regular recordable single entry classes. (No fee collected for sweepstakes or brace).
- CONSULT JUDGING PROGRAMS FOR TIMES OF JUDGING. Judging programs will be used as acknowledgement of entry. SHOULD SUCH ACKNOWLEDGEMENT NOT BE RECEIVED BY EXHIBITOR within a reasonable time, please notify the Show Secretary.
- DOGS MAY ARRIVE ANY TIME PRIOR TO SCHEDULED TIME OF JUDGING. Dogs not required for further judging will be excused. JUDGES WILL NOT WAIT for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.
- THE GREEN BAY SHETLAND SHEEPDOG CLUB, INC. assumes no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs or property. GBSSC further assumes no responsibility for injury to children. PARENTS/GUARDIANS MUST KEEP THEIR CHILDREN UNDER CONTROL ON THE SHOW GROUNDS.
- DOGS, WHICH, ACCORDING TO THEIR OWNER'S RECORDS, have completed the requirements for a championship after the closing of entries for the shows, but whose championships are unconfirmed, may transfer from one of the regular classes to the Best of Breed competition, provided this transfer is made by the Superintendent or Show Secretary at least one half hour prior to the scheduled start of any regular conformation judging at these shows (Chapter 14, Section 6 of the Dog Show Rules).
- IF A BITCH ENTERED IN THE OBEDIENCE OR RALLY CLASSES comes in season after the Trial's closing date, the entry less \$5.00 will be refunded. This will be done upon receipt by the Show Secretary within seven days of the Trial, of Veterinarian's certificate stating the condition to have been in effect the day of the Trial.
- NO DOGS UNDER 6 MONTHS OF AGE will be allowed on the Show sites.
- OBEDIENCE & RALLY CLASS PRIZES: Qualifying scores required for ALL prizes. In designating obedience prizes, "dog" means either sex. In case of tied scores, the prize shall be awarded to the winner of a run-off competition.
- THE GREEN BAY SHETLAND SHEEPDOG CLUB, INC. asks your cooperation in making use of the exercise pens and in maintaining the cleanliness of the grounds and premises so as not to jeopardize the future use of these show sites. ANY EXHIBITOR FAILING TO ADHERE TO THIS POLICY WILL BE SUBJECT TO A FINE OF \$50.
- AN ADULT (parent or guardian) MUST sign the entry form for any Junior Handler and/or any dog solely owned by a minor. Trophies MUST BE PICKED UP the day of the shows. NONE will be mailed.

SWEEPSTAKES RULES

- This Sweepstakes is open to all Shetland Sheepdogs who, on the day of the Show, will be no less than 6 months old and under 18 months of age.
- No dog which has completed the requirements of an AKC Championship prior to the date of judging may compete in this Sweepstakes, and any Sweepstakes entry fee submitted for such dog shall be refunded upon request of the dog's owner or agent, if such request is received by the Show Secretary no later than the closing date of the Show. For the purpose of those rules, the date of record for the Championship shall be the date of the show at which the dog won its final points.
- All Sweepstakes entries MUST also be entered in a regular class. "Sweepstakes" must be indicated on the entry form under "Additional Classes".
- Should it be found that an ineligible dog has received an award in the Sweepstakes, the person to whom such award was presented shall make restitution to the GBSSC and such award shall be deemed to have been won by the dog judged second to the dog declared ineligible. The prize money and other awards shall then be redistributed to conform to the rules regarding the Division of Prize Money.
- Classes will be as follows: DIVIDED BY SEX
 - Puppies, 6 months and under 9 months & 9 months and under 12 months
 - Juniors, 12 months and under 18 months
- BEST IN SWEEPSTAKES competition will be held for the winners of the sweepstakes classes. After selection of Best in Sweepstakes, the Runner Up to Best in Sweepstakes shall be selected from the remaining class winners. The Runner Up will receive no additional prize money, but will be awarded a rosette.

DIVISION OF PRIZE MONEY

- The prize money (adjusted entry fees) shall consist of all Sweepstakes entry fees less 20% for the GBSSC, for operation expenses. The Sweepstakes winner shall receive 25% of the adjusted entry fees. The remaining prize money shall be divided among the classes in the ratio determined by dividing the number of dogs in the class by the total number of dogs entered in the Sweepstakes.
- Within each class, only the first place winner will be awarded any prize money.

No adjustments to prize money will be made after entries close.

AGREEMENT

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents or any other persons. I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

Instructions

- (Variety)** If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering; i.e., Cocker Spaniel (solid color black, ASCOB, parti-color); Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.); Dachshunds (longhaired, smooth, wirehaired); Collies (rough, smooth); Bull Terriers (colored, white); Manchester Terriers (standard, toy); Chihuahuas (smooth coat, long coat); English Toy Spaniels (King Charles & Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
