Obedience & Rally Move-Ups

After a dog earns a title, it may be moved up to the next class in a future trial even though the closing date for the trial has passed. This move up may be requested if, according to the owner's records, the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. The request for a move-up must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Move-ups may be approved, provided the next level of class and judge is available and the class has not reached its limit.

Move-up forms may be downloaded from the AKC website (www.akc.org) and/or will also be available at the trial secretary's table.

FRIDAY - Please bring a mat or rug to place under your crates. All tables and chairs must also have rubber feet to protect the mats.

- NO DOGS UNDER 6 MONTHS OF AGE will be allowed at either of the Show sites.
 - There is **NO SMOKING** allowed in either of the show buildings. This will be strictly enforced.
 - Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment."

From the North: Hwy 41 South to Exit #129, Breezewood Lane. Turn right onto Breezewood Lane and continue to Hwy 76. Turn left onto Hwy 76 (in Oshkosh becomes Jackson St) and continue to Packer Avenue (located between His Church & Fox Valley Thrift Shoppe). Left onto Packer Avenue to Oshkosh Kennel Club, which will be on the left.

From the South: Hwy 41 North to Exit #120, Hwy 45/10 (Algoma Blvd). Turn right onto Hwy 45/10 (Algoma Blvd) and continue to County T. Turn right onto County T and continue to County Y (Sunnyview Road). Sunnyview Road to Hwy 76 (Jackson St); turn right onto Hwy 76 and continue to Packer Avenue (located between His Church & Fox Valley Thrift Shoppe). Left onto Packer Avenue to Oshkosh Kennel Club, which will be on the left.
