Obedience & Rally Move-Ups

After a dog earns a title, it may be moved up to the next class in a future trial even though the closing date for the trial has passed. This move up may be requested if, according to the owner's records, the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. The request for a move-up must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Move-ups may be approved, provided the next level of class and judge is available and the class has not reached its limit.

Move-up forms may be downloaded from the AKC website (www.akc.org) and/or will also be available at the trial secretary's table.

Please bring a mat or rug to place under your WIRE crates. All tables and chairs must also have rubber feet to protect the mats.

- NO DOGS UNDER 6 MONTHS OF AGE will be allowed at the Show site.
 - There is **NO SMOKING** allowed in the show building. This will be strictly enforced.
